Though there continue to be industry-wide challenges and hurdles triggered by the COVID-19 pandemic, witnessing your acts of thoughtfulness, compassion, and philanthropy while you managed the pandemic's personal impact on your own lives has been truly inspirational. For the ninth consecutive time, we earned national recognition for patient safety with an "A" Hospital Safety Grade from the Leapfrog Group. We were also one of only two Massachusetts hospitals named by the Leapfrog Group as Top Teaching Hospitals. In addition, we earned a Five-Star Overall Hospital Quality Star Rating from the Centers for Medicare and Medicaid Services.

It is clear to us that your commitment to Milford Regional Medical Center knows no bounds. We never cease to be amazed by the enthusiasm and determination with which you help us overcome whatever barriers we face and make great things happen. We are deeply grateful for your continued support, and look forward to updating you as we begin to move forward with improvement and expansion projects to meet our community's growing need for services.


Sandy says that a community-based organization that invites the people it serves to become involved in their work is "compelling and inspiring."

Currently an instructor and lecturer at Northeastern University, Dr. Berardi's distinguished academic career has involved both teaching and administrative roles in which he has helped shape the futures of countless individuals. 
Dr. Berardi notes that he saw the invitation as an opportunity, and says that opportunity is growth.
